Legibility Matters Initiative

2nd identifier options:

- BLOCK print your full name, including first, MI and last name.
- 2. Use a stamp with the above information.
- 3. Print your dictation number.

This change gives the COE (Denver) pharmacist a legible contact name if they have questions about an order.

Here's what happens when the second identifier is not completed:

- Pharmacy will return the order to the patient care area for clarification prior to processing the order.
- The order will not be completed until the nurse authenticates the order with you. The unit secretary or CNS will check for the second identifier before you leave the unit. You can be called to come back to authenticate signature; if you have left the hospital, an RN may call for your verbal authentication. The RN will read the orders to you and state that these orders were signed by you, and then print your name or dictation number.
- Emergent or critical* medication orders for life-threatening situations

and AHP's must
include a prescriber's
signature plus a
second identifier.

(i.e. vasopressors, etc.) will still be processed immediately to avoid delay in therapy that could result in patient harm. Clarification from you still needs to be completed after the order is entered, followed by any correction in documentation.

- *Note: Critical orders apply to those drugs listed on the "Critical orders" policy at each facility and justification needs to be documented for auditing purposes.
- Telephone orders: If an RN takes a medication order from you over the telephone, the RN must also block print your full name or use your dictation number.

Sign up to always know when your patients come to EIRMC
What is it?



- An automatically generated fax or email to your office when your patient seeks treatment at EIRMC. It provides the following:
 - Cover sheet with patient name, date of visit, and contact information for medical records.
 - Discharge summary with discharge diagnosis, discharge disposition, and discharge instructions.
- Reports are batched and faxed daily.
- The report is "triggered" when a patient provides your name as their Physician.
